Subject: Submission of Audited Financial and Costing Data for the period ending on 31st March, 2016 for new study of 580gm Jute Bags.

Please refer to this office earlier letter No Jute CA/(4)/2016 dated 2nd August, 2016, in which this office has requested to submission of Costing Data as per format of Tariff Commission (TC) and financial data (bifurcated between April, 2015 to Nov, 2015 and from Dec, 2015 to March, 2016) w.r.t new study to be carried out by TC. TC officials has informed that since Financial Year 2015-16 has come to an end and mills have also submitted audited Annual Accounts hence the costing data and the financial data for the new study of 580gm Jute Bags (Type B & Type A) should be resubmitted taking into consideration the audited annual accounts figures for 2015-16 and not provisional figures.

In this regard you are requested to submit the fresh copy of Costing Format as per TC Format (and the Financial data bifurcated between 8 months (April, 2015 to Nov, 2015) and for 4 months (Dec, 2015 to March, 2016) duly certified by practising Chartered Accountant/Cost Accountant with full particulars (Name, Membership Number, Stamped, signed) and also signed, stamped and with full Name, address, DIN number, of the Director within 21st December, 2016 positively by 16:00 Hrs to Director (Cost) or Deputy Director (Cost). All data should be submitted in duplicate complete in all respect which would be forwarded to TC. Hence Mill/Companies/Units should not write stating that "it was already submitted earlier reply".

IJMA is requested to coordinate with these Mills and ensure they submit all data duly filled in signed and stamped within the time frame.

In this regard for any type of clarification you may meet Director (Cost) on 9th December, 2016 at 11.00 Hrs in Office.
