In order to complete the last rake of UP's first indent to Gazipur City, six wagons of Banda/Agra (Stations of 2<sup>nd</sup> indent) were sent to GHAZIPUR CITY (a Stations of 1<sup>st</sup> indent) , details of which is tabulated below:
