The following amendments are hereby authorized to all Production Control cum supply order mentioned under reference:-

Regarding “Last Date Of Inspection and Last Date Of Despatch” against clause 7 (c) and 7(d).

**FOR** : - Existing entries.

**READ** : - On or before **31.01.2017** for inspection and dispatch of leftover quantity, **without Liquidated Damage but with Lower Price.**

The above extension of delivery date will also be subject to the following further conditions:-

- That no increase in price on account of any statutory increase in or fresh imposition of Cess (JMDC), Sales tax or on account of any other tax or duty leviable in respect of the stores specified in the said Production control cum supply orders which takes place after the date of original delivery period shall be admissible on such of the said stores which are delivered after original delivery period.
  - But nevertheless the purchaser shall be entitled to the benefit of any decrease of price on account of the reduction in or remission of Cess (JMDC), sales tax or on account of any other ground as stipulated in the price variation clause which takes place after the expiry of the above mentioned date namely original delivery period.
  - This extension is further subject to condition that Jute Commissioner office, Kolkata reserves the right to charge liquidated damage for delay in supply at the rates specified under payment terms of this Production Control cum Supply order.
  - All other terms and condition of the supply order shall remain unaltered.
