Sub:-Linkage of Raw Jute procured by Jute Corporation of India(JCI) with B-Twill allocation.

Whereas, under clause 5(1) of the Jute and Jute Textile Control order, 2016; the jute mills are directed to purchase the raw jute in a specified ratio from Jute Corporation of India on the terms and conditions specified by JCI in their sale contract and a compliance report to be sent to Office of the Jute Commissioner.

2. Whereas, many jute mills were found to have defaulted on their commitment to purchase raw jute from JCI in accordance with clause 7(1) specified in the Production-cum-Supply Order(PCSO).


3. In view of the default, the 10% value bill of such defaulting jute mills has been withheld by O/o the Jute Commissioner.

4. Whereas, representation has been received from the industry requesting the release of the withheld payment in advance so that the same may be used by the mills to fulfill their obligation to purchase raw jute from JCI. The jute mills have cited the issues faced by them in managing their working capital in support of such request.

5. After carefully examining the issue raised in the representations and in order to facilitate the jute mills to make the payment to Jute Corporation of India to purchase the raw jute under linkage, it is decided to release the 10% withheld amount to the jute mill after submission of declaration in **Annexure I**.

6. The jute mills must make payment for the raw jute to JCI after release of withheld amount within 5 working days of release of payment form o/o Jute Commissioner. In case the jute mill does not make the requisite payment to JCI within the stipulated time period, the same amount as released earlier shall be withheld from 90% payment due to the mills.

7. The above instructions shall only be applicable to the jute mills which are currently in operation and shall not apply to the mills which are closed or having suspension of work.
