

Notice under Clause 9 of Jute & Jute Textiles Control Order, 2016

1. In exercise of the powers conferred under clause 9(1)(a) of Jute & Jute Textiles Control Order, 2016, and in supersession of this office circular of even number dated 24.09.2024; I, Moly Chandan Chakraborty, Jute Commissioner hereby further direct you to furnish the details of receipt of the raw jute - both the Purchase Orders / Rukka and the details of receipt of the raw jute of Indian Origin procured by your mill, (except raw jute procured from JCI under Linkage); in the format given in **Summary Sheet, Annexure-I, and Annexure-II** enclosed herewith.
2. The requisite information for a month must reach Office of the Jute Commissioner by 3<sup>rd</sup> day of the next month i.e. the information of all the Purchase orders/ Rukka and the receipt of raw jute from period of 1<sup>st</sup> to 30<sup>th</sup> November 2024 must reach this office by 3<sup>rd</sup> December, 2024.
3. You are directed to update the report as required in **Annexure I and Annexure II** daily on the portal regarding purchase orders/Rukka and receipt of the raw jute in the module developed on the Jute SMART portal. The information on the portal must match with the compiled information sent by you before the 3<sup>rd</sup> day of the subsequent month.
4. If you fail to comply with the provisions of this order, you shall be punishable under clause 11 of Jute & Jute Textiles Control Order, 2016 read with Section 7 of the Essential Commodities Act, 1955.
