Subject: Submission of Monthly Import Returns - reg.

Whereas, as per the Jute Import Order of 23rd September 2019 issued by O/o Jute Commissioner, the importers are required to register with o/o Jute Commissioner. As per the para 4 of the order, the importers are required to file a monthly report on the imported goods as per Annexure II of the said order. Even if no import had taken place, a 'NIL' report was required to be filed.


2. Whereas, as per notification no. Jute (Econ)/IR/2015-III dated 1st August 2023, it was reiterated that every importer is required to submit the details of imports, sale/consumption and balances in the given format on a monthly basis.

3. However, it is observed that your firm, which has been registered as an importer had not submitted the monthly import return to this office.

4. A final opportunity is granted to your firm to file the pending returns by 31.07.2024. If the monthly returns in the prescribed format are not received by the date, the import licence issued by O/o Jute Commissioner shall be cancelled.

This issues with the approval of Jute Commissioner.

Subject: Submission of monthly returns in respect of imported raw jute and jute textiles-Reg.

It has been observed that some importers of raw jute and jute textiles are not submitting the monthly import return in Annexure II within stipulated time of **Ten (10) working days** of the end of every month as specified in the Jute Import Order of 23rd September, 2019 of Office of Jute Commissioner, Ministry of Textiles. If no import had taken place in the preceding month, "**NIL**" return is required to be filed.

The monthly return must mention in detail the entire chain of transactions from purchase of imported raw jute/jute textile to details of dispatch and subsequent sales. It shall be strictly ensured that all the participants in such transactions, except retail/end users, are registered with this office. Any person who contravenes any of the provisions of this Order or fails to carry out any direction or requisition made there under would be liable to be punished under section 7 of the Essential Commodities Act, 1955 which provides for punishment of imprisonment, fine or both.

The return must be duly signed with date and seal and must be submitted only in the prescribed (typed) format. The registration certificate would be revalidated in the ensuing month only after the receipt of monthly return in the preceding month within stipulated time, failing which the license would be liable to be cancelled without any reference.
