ORDER

O/o Jute Commissioner vide Notice dated 24-12-2024 had informed registered raw jute traders about further simplification of online return format and directed them to submit online fortnightly returns of purchase & sale of raw jute in the 'JUTE SMART' portal. It was directed in the said notice that the periodical returns to be submitted by traders of raw jute for period from 1st to 15th of the month should be submitted before 20th of the ongoing month & returns for the period from 16th to the end of the month should be submitted by 5th of the following month. It was also mentioned that if no trade has taken place or no stock is available, NIL return is required to be submitted within the stipulated date.

2. In this connection, attention is invited to this office Order dated 20-05-2025 (copy enclosed). Now, it has been observed that even after simplification of the return format, many registered raw jute traders have not been submitting their returns of purchase & sale of raw jute. Therefore, in exercise of the powers conferred under clause 9(1)(a) of Jute & Jute Textiles Control Order, 2016, I, Moloy Chandan Chakraborty, Jute Commissioner hereby direct you to furnish the details of stocks of raw jute every fortnight through 'JUTE SMART' portal in the format given at Annexure I of the Notice dated 24-12-2024. You can do so by logging in to the 'JUTE SMART' portal using your User ID and Password.

3. It has been informed by some traders/stockists/balers that they have been unable to login on JUTE SMART portal due to technical issues. In that case, the same may be resolved by coordinating with the technical team of o/o Jute Commissioner. Alternatively, in case you are not able to submit return online on JUTE SMART portal due to any reason, the signed return must be submitted by you in the prescribed format so as to reach o/o Jute Commissioner by the dates given above. You shall be responsible for ensuring that the returns reach o/o Jute Commissioner by the given deadlines. Non-provision of information or delay in provision of information shall be viewed as deliberate non-compliance.

4. If you fail to comply with the provisions of this order, you shall be punishable under clause 11 of Jute and Jute Textiles Control Order, 2016 read with Section 7 of the Essential Commodities Act, 1955.
