**Subject:** Penalty and Incentive for Supply Performance of the Jute Mills – reg.

Jute Commissioner has issued PCSOs to the jute mills as per clause 4 of Jute and Jute Textiles Control Order,2016 considering their installed capacity and commitment submitted by the respective jute mills. It has been observed that many jute mills have failed not only to supply the jute bags within the delivery period as given in PCSOs but also within 30 days of the date of PCSO. Further, the jute mills have been supplying less quantities than what were committed by them. Needless to say, that such non-performance has potential to adversely impact the MSP operations in States.

Therefore, to ensure that the supplies are made by the jute mills in a timebound manner; it is desirable that the order allocation is dynamic considering the operational performance of the jute mills in supply of jute bags. The penalty and incentive mechanism to account for supply performance has been revised as follows:

- 1. The Backlog of Orders shall be defined as the total orders placed to the jute mills, which have not been inspected and passed.
- The Backlog Supply Ratio shall be defined as the following Backlog Supply Ratio = Backlog of Orders / (Number of inspected and passed bales in the preceding 30 days period)
- 3. The Benchmark Backlog Supply Ratio shall be the overall industry Backlog Supply Ratio. For example, if the industry as a whole had got 3 lakh bales inspected and passed

- in the preceding 30 days and the current backlog of orders available with industry is 6 lakh bales, the benchmark Backlog Supply Ratio shall be 2.
- 4. Similarly, the Backlog Supply Ratio for each individual jute mill shall be calculated using the formula given at point no. 2 above.
- 5. If the Backlog Supply Ratio for the jute mill exceeds the following cut-off ratio, the mill shall not be considered for allocation:

Cutoff Ratio = Max (1.25,1.25 x Benchmark Backlog Supply Ratio)

That is the Cutoff Ratio is 1.25 or 1.25 times the Benchmark Backlog Ratio whichever is higher.

The calculations done using the above methodology as on 15<sup>th</sup> April 2025 are attached at Annexure I for information.

- 6. These orders shall be distributed proportionately in accordance with their allocation ratio among all the other mills which have the Backlog Supply Ratio below the Cutoff Ratio.
- 7. If the mill was closed due to strike/suspension of work, the quantity inspected and passed on preceding 30 days except the period of strike/suspension of work shall be considered. However, it shall be applicable only when the intimation is given to the Jute Commissioner with the documentation and within the period specified in the extant rules and regulations.

This issues with the approval of Jute Commissioner.
