Sub: Representation of Jute Mills-reg.

Sir,

This is with reference to this office letter of even number dated 07-08-2025 on the above-mentioned subject.

It has been observed that with respect to clause (iii) of the Policy, a number of mills have PCSOs pending for inspection which are 60 days or older. Further, difficulties have been expressed regarding compliance with change in policy due to various issues. Therefore, one time relaxation provided vide letter 18.08.2025 is extended till 30<sup>th</sup> September 2025. These mills shall be considered for allocation provided their backlog supply ratio is less than 1.25 or 1.25 times the benchmark backlog ratio, whichever is higher.

The mills having backlog pertaining to PCSOs issued upto 1.8.2025 are directed to get them inspected immediately. From 1<sup>st</sup> October 2025, the mills having backlog for the PCSOs issued before 60 days shall not be considered for allocation irrespective of their backlog supply ratio in terms of policy dated 7<sup>th</sup> August 2025.

Further, it is reiterated that the PCSOs once issued shall not be cancelled and the mills are required to supply against those PCSOs. The non-supply against the PCSOs is considered as an 'unfair practice' in terms of clause 2(h) of Jute and Jute Textiles Control Order, 2016 and your mill may be liable for proceedings in terms of the relevant legal provisions in case of non-supply.

This issues with the approval of the Jute Commissioner.
