**Minutes of the meeting held in the office of the Jute Commissioner on 02-11-2023 under the Chairmanship of the Jute Commissioner for framing new policy for B-Twill allocation of jute bags**

List of participants is enclosed at Annexure- 'I'

2. Initiating the discussions, Jute Commissioner stated the need for framing the new policy for B-Twill allocation.
3. Deputy Chairman, IJMA suggested that the outdated machine for production of Type- 'B' bags and 5&1/2" spinning frames may be phased out in a time bound manner. It was informed that production turnover comprises the revenue from sale of jute goods, from which the cost of traded jute goods i.e the procurement of jute goods other than raw jute is subtracted. The revenue also takes the domestic sales and exports into account. Therefore, using production turnover may be in consonance with policy to take into account private sale & exports when deciding allocation.
4. It was unanimously decided that the data on the following may be obtained before new policy for B-Twill allocation:-
  - i. Supply Backlog of the previous month
  - ii. Production Turnover (April'22 to March'23)
  - iii. Electricity consumption (April'22 to March'23)
  - iv. Number of working days (April'22 to March'23)
5. It was also decided that all jute mills would be asked to submit the above information in a time bound manner. All mills may be directed to provide the information at Point (ii) to (iv) by 30<sup>th</sup> November 2023.
6. The meeting ended with vote of thanks to the Chair.
