2. 3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the

OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . 5. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. - 1. Jute Mills registered in India having **BIS license** to manufacture 775 gram light weight new jute sacki ng bags for packing 50 kg Ragi, Mustard Seeds and Niger Seed, conforming to IS 18161:2023
- 2. Jute mills registered under **Goods and Service Tax Act** in India are only allowed to participate in e-t ender.
- 3. Jute mills having registered offices with legal presence in India.

- 4. The jute mill should not have been black-listed by Central Government / any State Government / PSU' s of Karnataka or any other state /any private firms.
- 5. The jute mil shall have an experience of 2 years in supplying gunny bags to any Govt. Organization.
- 6. The jute mill should have achieved a minimum average annual turnover not less than Rs.75.00 Crores in last 3 financial years (2021-22, 2022- 23 and 2023-24) pertaining to jute bags and related products.
- 7. The jute mill's minimum production capacity should be 100000 jute bags (775 grams) per day.
- 8. The jute mill must empanelled with Jute Commissioner, Kolkata for supplying gunny bags.
- 9. The jute mills using jute of Indian origin to manufacture gunny bags are only allowed to participate in e tender.
- 10. Earnest Money Deposit of 2% of the value of tender and security deposit of 5% of the work order qua ntity shall be paid by the bidder.
- 11. All pages of the tender document duly signed (with seal) by authorized person of the jute mill shall b e submitted, towards its acceptance of terms and conditions.
- Pre bid meeting will be held on 24.01.2025 at 11:30 am at KFCSC Head office, 16/I, Millers Tank Bed Area, Vasanthanagar, Bengaluru, on hybrid mode (bidders may attend in person or through virtually – link will be posted on KFCSC official website <u>https://kfcsc.karnataka.gov.in</u>)
- 13. The District wise quantity mentioned in the tender document is tentative. It may vary according to th e actual procurement of food grains in particular district.
- 14. The total gunny bag requirement shall be split into three orders, each allocated to a different bidders and work orders shall be issued to L1/ L1 matching two other Jute mills in the following proportions.
 - 1. L1 Bidder 50% of the total quantity
 - 2. L2 Bidder 30% of the total quantity (only upon agreed to L1 rates)
 - 3. L3 Bidder 20% of the total quantity (only upon agreed to L1 rates)

- 17. The jute mills shall comply all specifications mentioned in IS 18161:2023. The standard document upl oaded in ATC.
- 18. Safety stitch is mandatory: A line of safety union stitch shall be provided at the inner edges of the her akle stitches (see IS 9113). The number of safety union stitches per decimetre shall be 10 ± 1 .
- 19. Security Deposit in the form of Bank guarantee from nationalized banks at the rate of 5 % of the total value of work order and the same should be submitted to the KSFCSC within 3 days from date of aw ard of contract and the validity of Bank Guarantee shall be for a period of 18 months.
