Subject: Mandatory Selection of Type of bags (A or B) being offered for predispatch inspection during online generation of I-Call & I-Note in Jute-Smart portal - regarding

Sir,

This is with reference to this office letter of even number dated 14th June 2024, wherein at para 4(a) it was mentioned that Jute mills should offer either Type-A or Type-B B-Twill jute bags for inspection. i.e. in a single lot, there must be a single type of jute bags. Separate I-Calls must be generated for Type A and Type B jute bags.

In this connection, it may be noted that necessary provision has been made in online Jute-Smart portal for selecting the 'Bag Type' being offered for inspection during generation of I-Call by the jute mills. Therefore, while generating the I-Call, the mill company must select the correct type of bag which has been manufactured and is being offered for inspection. After pre-dispatch inspection, the concerned Inspection Agency should ensure that the Inspection Certificate issued is as per the 'Bag Type' provided in the I-Call. A screenshot of creation of such provision in online Jute-Smart portal is annexed at Annexure-A, for your reference.

In view of the above, all the jute mills and concerned inspection agencies are advised to adhere to the above instructions while generating I-Call & I-Note and input the correct type of bag being offered for pre-dispatch inspection. It must be ensured by the jute mills and the inspection agencies that the bales offered for inspection are correctly identified by their Type in the I-Call.

This issues with approval of the Jute Commissioner.


