Reference is invited on the representation of Indian Jute Mills Association (IJMA) Vide Letter No. IJMA/19092023/Payment Terms/K-46/690-D/02 dated 19/09/2023. On receipt of approval of Ministry of Textiles vide letter No. J-9/8/2020-Jute Section dated 03/11/2023 this office notifies the following.

The approval of the recommendation of Joint Committee of Department of Food and Public Distribution and Ministry of Textiles in the meeting held on 12/10/2023, to ease the distress situation of jute mills , as short term measure **95% advance payment may be given until the 1st December, 2023**. In this regard jute mills are required to submit an undertaking (given in the Annexure-1) to make up any loss to any organization due to poor quality of their supply. Office of the Jute Commissioner will remain constant touch with the consignee for detecting immediate fault in quality. Therefore, any bills generated on or after 9th November, 2023 upto 1st December, 2023 for supply of jute bags shall be for release of 95% of admissible amount and 5% of the amount shall be released after specified period in terms of conditions as prescribed in PCSO in case no complaint is received.

The same would be without prejudice to any other action which Jute Commissioner may initiate against the jute mills company, for any violation under the Jute and Jute Textile Control Order 2016 or any other Order passed by the Jute Commissioner or any other authority of Government of India from time to time.
