Sub: Procurement of jute bags for packing of food grains through GeM portal, registration reg.

This has reference to this office letters of even number dated 18-11-2022, 19-06-2023, 13-11-2023 & 29-05-2024 informing you that Government of India has issued an order under Clause 3 of the JPM Act, 1987 stipulating, among others, "Initially 10% of the indents for foodgrains are to be placed through reverse auction on the GeM portal".

- 2. In this regard DF&PD vide their letter dated <u>05-06-2024 has informed that State Govt. of Chhattisgarh and Telangana will procure 0.30 lakh bales and 0.20 lakh bales of jute bags respectively through GeM portal for the KMS 2024-25 season. It is expected that the tender may be issued shortly on GeM portal.</u>
- 3. A number of letters have already been issued requesting the mills to register on GeM portal. Your attention is invited to this office letter dated 29-05-2024 (copy enclosed) wherein it was mentioned that in order to facilitate the registration, if any mill faces a technical difficulty, GeM has nominated Shri Vishwajeet Singh, Mob: 9818127781 (E mail: assistant-managerao2@gem.gov.in) as Single Point of Contact. From the O/o Jute Commissioner, Shri T.K.Mondal, Mob: 9831114656 (E mail: tusharmondal1962@gmail.com) is the Single Point of Contact to facilitate the registration of the mills.
- 4. You are therefore requested to register on GeM portal and inform the registration details to O/o the Jute Commissioner.
