<u>Sub:</u> Submission of information on payment of statutory dues to jute workers and prompt payment to jute farmers and balers.

It is informed that Government of India, Ministry of Textiles has issued an Order bearing S.O.No. 5459 (E) dated 26-12-2023 under sub-section (1) of section 3 of the Jute Packaging Materials (Compulsory Use in Packing Commodities) Act, 1987 stipulating that 100% foodgrains and 20% sugar are required to be compulsorily packed in jute packaging material. The Order further stipulates, among others, the following:

"To ensure that persons engaged in production of raw jute and jute packaging material are benefitted from the mandatory packaging, a suitable mechanism shall be devised for enabling payment of statutory dues to jute workers and prompt payment to jute farmers and balers on procurement of raw jute."

- 2. In this connection, this office vide letter dated 04-05-2023 and 26-04-2024 had directed your mill company to submit the detailed information on payment of statutory dues to jute workers in the requisite format by 20th of the following month as per stipulations of the Order issued under JPM Act, 1987.
- 3. The return has thereafter been reviewed and has been revised. The revised format of the return is attached at **Annexure I**. You are therefore directed to ensure that the returns pertaining to December 2024 onwards as per revised Annexure I is submitted to o/o Jute Commissioner by 20th of the following month without fail.
