
Notice under clause 9 of Jute & Jute Textiles Control Order, 2016

o/o Jute Commissioner vide Circular dated 13-09-2022 had informed registered raw jute traders about simplification of online monthly return format and directed them to submit online monthly return upto 10th of following month in the 'JUTE SMART' portal. After considering the request of the Jute Balers' Association, this office vide order dated 21-06-2023 again directed registered raw jute traders to submit their returns of purchase & sale of raw jute online on the 'JUTE SMART' portal. It has been observed that even after simplification of the return format, registered raw jute traders have not been submitting their returns of purchase & sale of raw jute. Now this office has decided to further simplify the return format (enclosed as Annexure-I).

2. In exercise of the powers conferred under clause 9(1)(a) of Jute & Jute Textiles Control Order, 2016, I, Moloy Chandan Chakraborty, Jute Commissioner hereby direct you to furnish the details of stocks of raw jute every fortnight in the format given at Annexure I through Jute SMART portal. You can do so by logging in to the JUTE SMART' portal using your User ID and Password.

3. The periodical returns to be submitted by traders of raw jute for period from 1st to 15th of the month must be submitted before 20th of the ongoing month. The returns for the period from 16th to end of the month must be submitted by 5th of the following month. It may also be noted that if no trade has taken place or no stock is available, NIL return is required to be submitted within the stipulated date.

4. If you fail to comply with the provisions of this order, you shall be punishable under clause 11 of Jute and Jute Textiles Control Order, 2016 read with Section 7 of the Essential Commodities Act, 1955.
