Kind attention is invited to the references cited.

Vide reference 1<sup>st</sup> cited indent was placed purchase of 1,50,00,000 B.Twill new gunnies/30,000 gunny bales of 50 Kgs. capacity with BIS quality specifications from O/o Jute Commissioner, Kolkata and it was informed that, the Corporation would make its own arrangements for transportation of jute gunnies from West Bengal Jute mills by road Movement. Accordingly, Jute Commissioner has issued a PCSO for 29000 bales vide reference 3<sup>rd</sup> cited.

Hence, vide reference 2<sup>nd</sup> cited tenders were floated for appointment of transportation contractors in three sectors of Telangana state for road movement of gunnies from west Bengal to all the Districts in Telangana State.

In view of anticipated delay in appointment of contractors through floated tenders , as an alternate arrangement, work order was issued to the existing contractor M/S.Tirumala transport contractors for transportation of gunnies vide reference 4th cited for movement of 6000 bales, out of which 4022 gunny bales have already been lifted from allotted jute mills as on date.

Further vide reference 5<sup>th</sup> cited eight contractors were appointed for 30 paddy procuring districts of Telengana for transportation of Gunnies from West Bengal through road movement. The details are as follows:
