This has reference to IJMA letter No K-46(Price)/600-D dated 8<sup>th</sup> February, 2016 on the above subject.

2. In continuation of this office letter no Jute (CA)/3/2005-XI dated 14<sup>th</sup> January, 2016, it is hereby informed that the price of B Twill sacking for the propose of processing of bills etc, the price declared in the month of December, 2015 for B Twill sacking (for both 665 gms and 580 gms sacks of Type A and Type B) shall be taken as ad-hoc price for February, 2016 and for the following months, till a decision regarding price capping is taken.

3. Since the matter is sub judice, the ad-hoc price shall be followed subject to further orders of the Hon'ble High Court, at Calcutta.

4. This is strictly, without prejudice to all our rights and contentions in the pending writ petition before the Hon'ble High Court at Calcutta.
