Sir,

As per request letter of Resident Rep of Food & Civil Supplies Department, Government of UP, Kolkata, this office has directed all loaders to despatch full rake load to each destination, as per priority and availability of GS TIN of the destination. At the moment GS TIN for only eight destinations is available. Seven destinations have been allocated to the loaders in the following manner:-
